

Privacy Statement Stroopwafelijzers.com

This is the privacy statement of Raffaele Nettuno trading under the name Stroopwafelijzers.com, hereinafter: Stroopwafelijzers.com. Stroopwafelijzers.com is registered with the Chamber of Commerce under number 08096209 and is located at Nering Bögelweg 23 (7418HJ) in Deventer (the Netherlands). This document explains how Stroopwafelijzers.com handles the processing of your personal data. Stroopwafelijzers.com takes the greatest possible care when processing your personal data.

Obtaining personal data:

If you use the services of Stroopwafelijzers.com, you provide a number of personal data to Stroopwafelijzers.com, or personal data is obtained from you in the context of the agreement. Personal data is understood to mean all data relating to an identified or identifiable natural person ('data subject').

Categories of personal data

Stroopwafelijzers.com processes the following categories of personal data:

- Personal identification data (name, address, phone number etc.);
- Company details, including VAT number and Chamber of Commerce number;
- Different delivery address;
- Other personal data provided by you yourself.

The aim/purpose of the processing

The personal data is processed by Stroopwafelijzers.com is used for the purpose of:

- Contacting you to inform you about the services you have purchased and their implementation;
- Performing its services;
- Improving its services;
- Making payments;
- Complying with legal obligations;
- Making marketing and communication expressions, including improving the website by analyzing visitor behavior on the website;
- Sending newsletters;

- Exchanging data with third parties for the performance of the service, insofar as this is necessary.

Lawfulness of processing

The processing of personal data is only possible on the basis of the following principles: (i) legal obligation, (ii) performance of an agreement, (iii) obtained (explicit) consent from the data subjects, and (iv) legitimate interest. Personal data is processed when providing Stroopwafelijzers.com services. - The Payment Provider, for the performance of the agreement. The categories of personal data that are processed are financial data.
- The Bookkeeper, for the performance of the agreement. The categories of personal data that are processed are contact and name and address data and financial data.
- Software suppliers, for the performance of the agreement. The categories of personal data that are processed are the contact and name and address details.
- Website manager, for the performance of the agreement. The categories of personal data that are processed are the contact and name and address details.
- Third parties engaged, for the performance of the agreement. The categories of personal data that are processed are the contact and name and address details.
- Manufacturer/Supplier, for the performance of the agreement. The categories of personal data that are processed are the contact and name and address details.

Right of data subjects

As a data subject you have the following rights:

Complaint
